LEGAL NOTICE OF PLANNED IMPROVEMENT

The Indiana Department of Transportation (INDOT) is developing plans for a proposed State Road (SR) 46 Erosion Control Project along Logan Creek, which consists of two sites in close proximity in Dearborn County. Site No. 1 is located 3.2 miles east of SR 1, and Site No. 2 is located 0.42 mile east of Site 1.

The purpose of this project is to provide a functional and structurally sound pavement and roadway embankment in order to maintain a safe travel way on SR 46. The need for this project is due to unstable and eroding slopes caused by stream morphology and fluvial bank erosion at the two project locations, Site No. 1 and Site No. 2. Side slope embankment failure at both sites has been an ongoing maintenance problem with several maintenance repairs having occurred at each site over the years. These attempted repairs have not provided an adequate correction for the problem. Pavement failure and guardrail post displacement are evident as a result of this ongoing erosion and slope failure, which is creating a safety hazard for the traveling public.

The project proposes to repair the roadway embankment erosion along Logan Creek at the two sites. The project will include, but not be limited to the installation of riprap, pile driving, installing new guardrail where guardrail presently exists, pavement repairs, and incidental construction .

The proposed construction of this project will require approximately 5.33 acres of new permanent right-of-way.

The maintenance of traffic (MOT) plan proposes to close SR 46 and detour traffic. An official state route detour utilizing SR 1, I-74, and SR 52 will be used during construction. Local roads may be used by local traffic. Access to all properties will be maintained throughout construction. School corporations and emergency services will be notified of closures prior to construction. The proposed start of construction is 2022.

The cost associated with this project is approximately \$804,856.00 which includes preliminary engineering, right-of-way, construction with both federal and state funds anticipated to be used. The Federal Highway Administration (FHWA) and INDOT have agreed this project falls within the guidelines of a Categorical Exclusion (CE) Level 2 environmental document.
